

### **SCCTM Educator's Scholarship**

The South Carolina Council of Teachers of Mathematics (SCCTM) will provide financial assistance of up to \$1,500 for a math teacher who is pursuing an advanced degree in mathematics, mathematics education, or elementary education with an emphasis in mathematics. # Outstanding Contributions to Mathematics Education Award Christie Reid



Clover School District's Math Instructional Supervisor Christie Reid was recognized Thursday, November 6, 2014 by the South Carolina Council of Teachers of Mathematics for her contributions to math education in the Palmetto State. Christie, who has worked for Clover School District for 10 years and Fort Mill School District for 9 years, was presented the state's highest math education honor, the Outstanding Contributions to Mathematics Education

As President of the South Carolina Leaders of Mathematics Education, she has been instrumental in leading math educators around the state as a new direction emerges for K-I2 mathematics instruction and assessment in South Carolina. Not only has she effectively kept district leaders of math instruction informed about potential legislation, she has been an outspoken advocate for ALL of the students of our state in appearances before various legislative entities such as the Senate Education Committee and the State Board of Education.

She has served in professional leadership positions and has spearheaded a number of proactive campaigns to inform the public of proposed legislation, has collaborated with other professional organizations to promote appropriate, rigorous curriculum and assessment standards for our students and led a successful campaign to reconfigure South Carolina's mathematics instructional materials adoption so that these materials might more closely align to the adopted curriculum standards. In addition, she has served on a number of national and statewide mathematics committees which have examined and created curriculum and assessment recommendations for the students of South Carolina, all while serving the needs of the students and teachers in her home district.

She embodies the type of professional educator of whom we should all aspire to be. Her soft-spoken manner belies her fierce warrior-like zeal in doing what is best for the students of our state. In my opinion, her actions make her an appropriate candidate for our profession's highest honor, The Outstanding Contributions to Mathematics Education Award.



## **Exciting STEM News**

On May 22, 2015, Alice Drive Middle School in Sumter School District became one of the first middle schools in the nation and the first middle school in South Carolina to earn STEM certification from the AdvancED Accreditation Commission.

Programs achieving a STEM (science, technology, engineering and math) certification have attained a highly sought-after mark of excellence. According to AdvancED, the purpose of establishing the AdvancED STEM certification is to provide schools and programs with a research-based framework and criteria for their awareness, continuous improvement and assessment of the quality, rigor and substance of the STEM educational program

Two years ago, Alice Drive Middle was named a 21<sup>st</sup> century STEM pilot school in collaboration with STEM Centers and the SC Coalition for Mathematics and Science. Alice Drive Middle School's principal, Jeannie Pressley says, "It is our vision to equip all students to reach their maximum potential in a competitive global marketplace." She credits the hard work and collaboration of her teachers, staff, and students for achieving this honor for their school.

AdvancED STEM certification is valid for a five-year period if the school renews its application with AdvancED each year. At the end of the five-year period, Alice Drive Middle can again apply for STEM certification.



### Clemson University Student Council of Teachers of Mathematics





#### **PAEMST**

The **Presidential Awards for Excellence in Mathematics and Science Teaching (PAEMST)** is the highest honors bestowed by the United States government specifically for K-12 mathematics and science (including computer science) teaching. Since 1983, more than 4,300 teachers have been recognized for their contributions to mathematics and science education. Awardees serve as models for their colleagues, inspiration to their communities, and leaders in the improvement of mathematics and science education. Up to 108 awardees may be recognized each year.

Presidential awardees receive a certificate signed by the President of the United States, a trip for two to Washington, D.C., to attend a series of recognition events and professional development opportunities, and a \$10,000 award from the National Science Foundation. The National Science Foundation administers PAEMST on the behalf of The White House Office of Science and Technology Policy.

Anyone--principals, teachers, parents, students, or members of the general public--may nominate a teacher by completing the nomination form available on the PAEMST website. To submit a nomination, you'll need the teacher's name, email address, and school contact information. If you know more than one teacher deserving of this award, you may submit more than one nomination. Teachers may also apply directly at <a href="https://www.paemst.org">www.paemst.org</a>.

The following are eligibility criteria for nominees. They must:

- Teach mathematics or science (including computer science) as part of their contracted teaching responsibilities at the 7-12th grade level in a public or private school.
- Hold at least a bachelor's degree from an accredited institution.
- Be a full-time employee of the school or school district as determined by state and district policies, with responsibilities for teaching students no less than 50% of the school's allotted instructional time.
- Have at least five years of full-time employment as a K-12 teacher during which mathematics or science (including computer science) has been a part of the applicant's teaching duties prior to the 2014-2015 academic school year.
- Teach in one of the 50 states, the District of Columbia, the Commonwealth of Puerto Rico, the Department of Defense Education Activity schools, or the U.S. territories as a group (American Samoa, Guam, Commonwealth of the Northern Mariana Islands, and U.S. Virgin Islands).
- Be a U.S. citizen or permanent resident.
- Not have received the PAEMST award at the national level in any prior competition or category.

Nominations for mathematics and science teachers of grades K-6 will open in fall of 2015. The **Nomination Deadline is April 1, 2016.** This date gives the nominated teacher time to prepare an application prior to the application deadline. The **Application Deadline is May 1, 2016**, for elementary school teachers (grades K-6).

## SCCTM Fall Math Conference 2015 Keynote Speakers



Ken May is Executive Director of the South Carolina Arts Commission, where he has served in several positions since 1985. He has been a panelist and site-visitor for the National Endowment for the Arts; a panelist, presenter, consultant, and facilitator for national, state, and local arts organizations; and a guest lecturer in the arts administration programs at the College of Charleston and Winthrop University. He is a member of the board of the National Assembly of State Arts Agencies, serves as a board


member and treasurer of South Arts (formerly Southern Arts Federation), is a founding member of the South Carolina Afterschool Alliance board, and is an active alumnus of the Diversity Leaders Initiative of the Riley Institute at Furman University. Before beginning his career in arts administration, he worked in the for-profit world, holding positions with ARA Services Magazine and Book Division and McGraw-Hill. Prior to his long sojourn in the realm of day jobs, he worked as a professional musician. He received undergraduate and master's degrees in music history and musicology from Florida State University.



Dr. Thomas T. Peters serves as Executive Director of South Carolina's Coalition for Mathematics & Science (SCCMS) founded by BMW Manufacturing Co., DuPont, Michelin North America and Duke Energy and hosted by the College of Engineering and Science at Clemson University. Among the initiatives managed by SCCMS is the S<sup>2</sup>TEM Centers SC statewide support network for economic and workforce development through STEM education. Additionally, with Tom as Principal Investigator, SCCMS manages a research grant funded by Boeing SC and focused on identifying instructional strategies in

disciplinary literacy to enhance student learning in middle school mathematics and science. Dr. Peters is a recipient of the Outstanding Leader in Science Education award from the National Science Education Leadership Association. He has applied his instructional, scientific, and management expertise a variety of settings including middle school, high school and university classrooms. Tom holds Doctorate and Masters degrees in Science Education and Bachelors degrees in the Teaching of Biology and in Ecology, all awarded from the University of Illinois at Urbana-Champaign.

### SCCTM Fall Math Conference 2015 **Keynote Speakers**



**Bob Horton is Professor Emeritus of Mathematics** Education at Clemson University. With degrees from the University of Wisconsin-Madison, Miami (OH) University, and the University of Cincinnati, he has long been interested in the effective use of technology in learning and teaching mathematics, equity in mathematics education, and inquirybased instruction. He has published dozens of articles in many mathematics education journals, been a frequent

speaker at state and national conferences, and was principal or co-principal investigator on more than \$2,000,000 in grants. He also chaired the dissertation committees of ten students who have completed their doctoral degrees in Curriculum and Instruction, with a focus on mathematics education. Among his numerous honors, he was named as one of the top ten professors in the country by the National Society of Collegiate Scholars Faculty of the Year Award and has received Clemson University's Student Government Excellence in Teaching Award and the Thomas Green Clemson Award of Excellence.



  can't find it, we'll look it up for you to see if
  you've ever been a member of our organization.
- The phone number you share with us is published in a limited distribution membership list for board members. If you do not want your phone number printed, then please let us know.
- 3. Include two e-mail addresses (school/home), the school or office where you work, and the county and district where you are employed. Your e-mail addresses will not be sold or shared for mass emailing purposes, but may be used by officers, committee chairmen, and Corporate Sponsors to contact you. Your conference badge will list the school where you work or the district, if you're not at a school.
- Select the level(s) of interest that fit your job or professional development needs. This information may be used for special interest mailings, such as Institute announcements, etc.
